WHERE: 3320 State Highway 49, Cool CA. : From Sacramento I-80 going East: in Auburn, take Elm Exit, Turn L at stop light, one block, L on High St (hwy 49). Follow signs to Cool . Just ½ mile past the town of Cool. This course is on the Beautiful Olmstead Knickerbocker trail that includes views of Sierra Nevada. Trail varies from single track to fire road, mostly rolling with a few of short/medium climbs - from easy to moderate. **CAMPING:** Overnight camping available \$15.00 space fee

I UNDERSTAND THAT I AM ENTERING THIS EVENT AT MY OWN RISK and upon acceptance of my application for entry in the above-described race, I acknowledge that I assume FULL RESPONSIBILITY for my own safety. I and my heirs, executors, and administrators, will hold the Ride and Tie Association, and all officers and directors, thereof, any member of the race management and race personnel, Cool Hills stables and all property owners/tenants whose land the race crosses BLAMELESS for any injury or loss to myself or my horse which occurs due to my participation and free from all liability for such injury or loss.
