TRAILS: \*\*GREAT TRAILS\*\* WITH THE COOPERATION OF MANY AREA LANDOWNERS, WE HAVE A GREAT TRAIL THAT CONSISTS MOSTLY OF FLAT, SANDY DIRT ROADS. WATER BUCKETS WILL BE AVAILABLE ALONG TRAIL. TERRAIN IS FLAT, SHOES ARE RECOMMENDED FOR THE LONGER DISTANCE THERE HAS BEEN SOME GRAVEL ADDED IN SPOTS, PLEASE CONSIDER YOUR PARTICULAR HORSE IF YOU'RE RIDING THE LD.

**DIRECTIONS:** US HWY #1 BETWEEN MCBEE AND PATRICK. FROM MCBEE IT IS APPROX. 7.5 MILES. If travelling North on US Hwy #1, LOOK FOR CAUTION LIGHT AT SIGN DESIGNATING RUBY RD. TURN LEFT, GO ABOUT 5 MILES, "THE WINERY" (CAMPSITE) IS ON RIGHT. **LOOK FOR AERC SIGNS.** 

This is our CURRENT CoVid-19 mitigation plan. As with anything and everything related to CoVid-19 it is a fluid plan.

- As much as possible maintain six (6) feet of distance from all humans.
- Wearing of face coverings when you can reasonably expect to NOT be able to maintain six (6) feet of distance from humans outside your crew / family / group is strongly recommended
- Wearing of masks is optional on the trail
- Hand sanitizer will be available, but you should bring your own.
- RIDER CARDS will be held in the vet check to minimize handling. Riders may view their card any time during the ride, and may pick their card up after the ride.
- We have designed a new pulse box area and procedure to allow for ease of keeping distance between riders.
- We request that only one handler accompany the horse through the vet check, but also understand the need for substitute runners, please "keep your distance".
- To help keep the amount of human and equine traffic down, there should be no "buddy" horses.
- NO RIDER MEALS at this time, only planning to feed staff.
- We will provide "ride meeting" information in packet and hold an in-person ride meeting / question session and New Rider's Meeting. Your participation in the ride meeting is therefore optional.
- We will hand out completion awards when you check in. Top Ten and First2Finish will also be handed out immediately post ride. Best Condition will be handed out when scoring is complete.

Please avoid congregating around the "office" / vet check area and spread out when setting up your crewing area. We have modified the space for these areas and will have other distance procedures in place. Also, only come to ride meeting if you have questions, <u>after reading what is in your packet</u>. We simply ask that you respect others concerns and use common sense. We strongly request that everyone pre-enter and pre-pay.
