4. Committees:

- a. Godfrey Sullivan Committee: Steve S Going to touch base with Godfrey Sullivan concerning the direction of Ride and Tie and will nominate a new committee member.
- b. Nominating Committee: Lani Approves of Courtney's schedule. Courtney went through the bylaws and made a schedule that fits that. Will be posted in the next newsletter.
- c. Vet Scholarship Committee: Greg getting bios and photos to publish with essays in the newsletters from 2022 winners. Will be published in the next newsletter. Gearing up for 2023 with Melinda, deadline will probably be January 15th.
- d. R&T/AERC Committee: Steve S Responded to Mike at AERC with our proposal, he agreed with everything, but did not agree with removing the \$2,500 a year donation. Should we negotiate down to \$1,500? Janice last year they hosted three webinars about ride and tie, and then posted them to be watched at any time. Have been giving us ad discounts as well and encouraging ride managers to add ride and tie to events. They have also published some of our articles in Endurance News. Janice also suggested asking them to have the AERC website to allow to sort for events including ride and tie, since it already sorts for distances. Also, suggestion that any horse that competes in any ride and tie of LD level or above, that horse would be credited with those miles as AERC miles also. - f. Horse Awards: Steve A At the championship, the horse of distinction awards were announced, and then mailed out to those not present.
- g. Publications: Bob Nothing to report currently.
- h. Technology: Janice In membership database, asking if there is a way to change the fact that any mentor became a lifetime member.
