

## Coollest Ride & tie and Equathon June 3,2023

**Trail:** Transverse the beautiful trails of Olmstead staging area fire roads and single track. We do our best to keep you on shaded and better footing trails.

**Olmstead Staging area.** 7200 St Florian Ct, Cool, CA 95614. Behind fire station. This is a \$10.00 daily fee parking. Overnight camping Friday only by arrangement with RM. Holiday Market (full service), restaurants, and feed store within walking distance. Standard porta potty, water troughs and water available. This event continues to be a **fund raiser** for trail stewardship and other community needs.

**Start time: 8:00**-Equathon Long course, **8:15** Ride & Tie 22 and 13 miles. **8:30** – 8-mile RAT & Equathon. Ride meeting: 6:30 pm June 2 and packet pick up. Brief ride meeting at 7:45am.

**Ride & Tie:** Two people one horse switching off pony express style or hang together. 8-mile RAT & Equathon may have tether rope and be led (children).

**Equathon:** Rider/runner start together. **Finish time** is horse pulse down time plus runner finish time combined. This is complicated so make sure recorded!

**IRON Equathon:** Finish time is **Horse pulse time plus run time combined.** May have crew pulse horse and vet horse. Give run time out to timer.

**Vetting: Traditional vetting required pre/post for mileage greater than 10 miles. One vet check at 13 miles.** 13 milers may elevate. **Important!** Pre-vetting 5:30-6:30 pm Friday and 6:15 am Saturday am required for Ride & Tie and Equathon participates participating in 21 - or 13 mile courses. Pulse and trot only for 9-mile Ride & Tie and Equathon.

- All participates must be a member of Ride and tie Association. Discount with current membership or with new membership for any one **new** to ride and tie Association with pre-registration at event. Go to [www.rideandtie.org](http://www.rideandtie.org) to renew. If renewing at event make check to Ride and tie association.
- All juniors must wear helmets.
- All dogs must be leashed.
- **All Vehicles must have parking pass visible! Cars in car lot only.**
- The park is open to public. Be courteous to hikers, bikers, riders, dog walkers, etc.

ENTRY Includes required vet check, great awards, snacks and drinks along with all that goes into putting on an event. Horse/Human water/snacks on course.
